Outcomes

- There are 6 exams. total. Nothing else. You will take 5 online exams., and a face to face final. Everything is explained below.
- Exam. 1 through 5 is online, in Courseden. You take it from anywhere you want.
- Exam. 1 is August 18th. It is a 60 minute exam. It is open from 9 am - 9 am the next day. It will be open for 24 hours. It will be 25 multiple choice questions (MCQ's), worth 1 point each. Once you start, the exam. will be open for the next 60 minutes. You have to finish it in one session. It will be Chapters 1 and 2 only. Be prepared with these 2 chapters. Cannot do it? Drop my class. There is no other choice.
- Exam. 2 is August 25th. A 60 minute exam., open from 9 am - 9 am the next day. It will be Chapters 3 and 4 only. Rest of the rules are the same as the previous exam.
- Exam. 3 is September 1st. A 60 minute exam., open from 9 am - 9 am the next day. It will be Chapters 5 and 6 only. Rest of the rules are the same as the previous exams.
- Exam. 4 is September 8th. A 60 minute exam., open from 9 am - 9 am the next day. It will be Chapters 7 and 8 only. Rest of the rules are the same as the previous exams.
- Exam. 5 is September 15th. A 60 minute exam., open from 9 am - 9 am the next day. It will be Chapters 9 and 11 only. Rest of the rules are the same as the previous exams.
- Final Exam.: It is a face to face final with me. I will conduct the exam. It will be 50 multiple choice questions (MCQ's), worth 1 point each. It is a 2 hour exam. It will be Chapters 12, 13, 14, and 15. There is no fee or charge for this.
- For this final exam., we will meet at 10 am, on Friday, September 24, 2021 in Roy Richards Sr. Hall, room # 102 Lecture Hall. Come to campus early, say by 9.30 am. It's safe. The exam. timing is rigid. It is the final exam. The exam. is open from 10 am to 12 pm, for 2 hours. I have reserved this lecture hall exclusively for your final exams. Put this in your calendar.
- EXCEPTION: If you cannot take the face to face final, you will have to take the final proctored by UWG ProctorU services. There is a fee for this. You will pay the fee. You will contact ProctorU services, and set up the time to take the exam. You can take the exam. online, but proctored by ProctorU, from 9 am (September 24, 2021) to 9 am (September 25, 2021). It is open for 24 hours. The exam. is 2 hours, and 50 multiple choice questions.
- The face to face final exam. in school (proctored by me) is free. There is no charge. Just show up and take the exam. There is a fee (which you will pay) only if you use UWG ProctorU services to take a proctored final.

- If you cannot take the final face to face, then you will have to take it with the UWG Proctoring services. You will fill out the form with them, decide your convenient time and take the exam. I will keep the final exam. open with our proctoring services from 9 am (9/24/2021) to 9 am (9/25/2021), for 24 hours.
- I repeat: If you want to take the online proctored finals, do your paperwork with UWG ProctorU services. I have emailed you the "How to" links. I have done my part of the paperwork with them. It is ready.
- I REPEAT: THIS PROCTORED EXAM. HAS A FEE. You will pay the fee. The face to face exam. conducted by me in our classroom, of course has no fee.
- Cannot do it? Drop my class. There is no other choice. There are seats open in other sections of the same class.
- If you take my class, I will assume you read this, understood it and agree with it. Please do not complain about any of this later on. It is very unfair to me. I am spelling out everything in plain simple English here and also in my syllabus, in Courseden. Read that too.

Breakdown

Assignments

The entire course outline, syllabus, reading list, important topics, power points, practice questions etc. are all spelled out in Courseden. There are no essay exams, no assignments, no home works, no projects, no case studies. Only 6 exams.

Assignment:

Read the 2 chapters assigned (per week) for the online exam. scheduled for that week.

Read the topics from the "Reading List", again and again. They are important.

Practice the questions (I assigned as practice questions) at the end of each chapter.

Ask me questions.

Take the 5 online exams. as scheduled. Everything is spelt out in Concourse and in Courseden.

Then come to school on September 24, 2021, at 9.30 am to take a face to face final conducted by me. You have to come to school (on my account) this "ONE DAY ONLY." Details are in the syllabus.
